#### RULES AND REGULATIONS AND GENERAL INFORMATION

"Every class offered herein which is covered by the rules and specifications of the current USEF Rule Book will be conducted and judged in accordance therewith"

LIFE, SENIOR ACTIVE AND JUNIOR ACTIVE MEMBERS SHALL BE ELIGIBLE TO PARTICIPATE IN ALL CLASSES AT REGULAR COMPETITIONS, EVENTING COMPETITIONS AT THE MODIFIED LEVEL OR ABOVE, AND COMBINED DRIVING COMPETITIONS AT THE ADVANCED LEVEL, DRESSAGE, REINING, AND VAULTING COMPETITIONS AND ENDURANCE RIDES. A NONMEMBER MAY PARTICIPATE AS A HANDLER, RIDER, DRIVER, OWNER, LESSEE, AGENT, COACH OR TRAINER AT REGULAR COMPETITIONS, EVENTING COMPETITIONS, DRESSAGE COMPETITIONS. REINING COMPETITIONS AND COMBINED DRIVING COMPETITIONS AT THE ADVANCED LEVEL UPON PAYMENT OF A \$45.00 SHOW PASS FEE. PARTICIPANTS IN THE FOLLOWING CLASSES ARE EXEMPTED FROM THE REQUIREMENTS OF THIS RULE; 1) LEADLINE; 2) EXHIBITIONS; 3) GAMES AND RACES; 4) CLASSES FOR 4-H MEMBERS; 5) WALKTROT(exception: Friesian performance FR222) AND ACADEMY CLASSES. (Academy Classes are classes limited to horses used regularly in a lesson program; 6) USDF INTRODUCTORY LEVEL TESTS, PAS DE DEUX AND QUADRILLE CLASSES; 7) NHRA ENDORSED REINING COMPETITIONS; 8) OPPORTUNITY CLASSES; 9) CITIZENS OF OTHER NATIONS, WHO HAVE PROOF IN ENGLISH, OF CURRENT MEMBERSHIP IN GOOD STANDING OF THEIR OWN NATIONAL FEDERATION; 10) USEA BEGINNER NOVICE DIVISION; AND 11) ASSISANT HANDLERS IN DRESSAGE SPORT HORSE BREEDING CLASSES.

#### **USEF Entry Agreement**

By entering a Federation licensed Competition and signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Vaulter or Longeur and on behalf of myself and my principals, representatives, employees and agents, I agree that I am subject to the Bylaws and Rules of the United States Equestrian Federation, Inc. ("the Federation") and the local rules of the Tucson Fall Festival and Classic. I agree to be bound by the Bylaws and Rules of the Federation and of the competition. I will accept as final the decision of the Hearing Committee on any question arising under the Rules, and agree to release and hold harmless the competition, the Federation, their officials, directors and employees for any action taken under the Rules. I represent that I am eligible to enter and/or participate under the Rules, and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry, the Federation and/or the Competition may use or assign photographs, videos, audios, cablecasts, broadcasts, internet, film, new media or other likenesses of me and my horse taken during the course of the competition for the promotion, coverage or benefit of the competition, sport, or the Federation. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation. The construction and application of Federation Rules are governed by the laws of the State of New York, and any action instituted against the Federation must be filed in New York State. See GR 908.4

I have carefully read this document in its entirety, understand all of its terms and conditions, and know it contains an assumption of risk, release and waiver from liability, as well as a hold harmless and indemnification obligations.

BY SIGNING BELOW, I AGREE that I have read, understand, and agree to be bound by all applicable Federation Bylaws, rules, and policies including the USEF Safe Sport Policy and Minor Athlete Abuse Prevention Policies (MAAPP) as published at www.usef.org, as amended from time to time, as well as all terms and provisions of this Prize List. If I am signing and submitting this Agreement electronically, I acknowledge that my electronic signature shall have the same validity, force and effect as if I affixed my signature by my own hand.

The Horse Show Management reserves the right to itself to interpret all questions and conditions in regard to or arising out of an incident to the show without claims for damages or recourse of any kind. All questions not covered in these Rules and Regulations shall be decided by the Horse Show Management, their decision to be final.

The Horse Show Management reserves the right to limit entries, refuse, accept conditionally, or to cancel any entries; disqualify any riders or exhibitors, prohibit exhibition of entries, and cancel award prizes, without claim for damages; to change any course, to add a dotted line, to cancel or combine any classes, or to reschedule classes, after due notice to exhibitors; to change rings or judges; to change specifications in jumper classes in order to facilitate the time schedule or as competition warrants, or make any changes management deems is in the best interests of the show.

Every horse on the show grounds will be under the control of the Horse Show Management, but Management will, in no case, be responsible for any loss or damage that may occur, and it shall be a condition of entry that each exhibitor shall hold the Horse Show, its members, directors, employees, sponsoring entities and facility harmless for any loss or accident to his/her horse, horses or equipment which may occur from sickness, fire or otherwise.

All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. As of January 1, 2019 all USEF members 18 years old and older, with a competing membership must complete SafeSport Training in order to be eligible to participate in USEF activities, including competitions. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. <u>HEALTH REQUIREMENTS:</u> All horses entering the state of Arizona must have a current health certificate. For any questions, please contact the Arizona State Veterinarian's Office at 602 542 4293

Vaccination Requirements (per the USEF GR-845 Equine Vaccination Rule [CHAPTER 8F Welfare of the Horse] Rule Changes Effective 12/1/15)

At Federation licensed competitions, horses entering the grounds must be accompanied by documentation of Equine Influenza Virus and Equine Herpes Virus (Rhinopneumonitis) vaccinations within six months prior to entering the stables. Horses not in compliance with this rule may be required to leave the competition grounds upon request by Competition Management. Documentation should consist of one of the following methods mentioned below. The frequency of vaccine administration should be per the vaccine manufacturers' or veterinarian's recommendations. It is recommended that vaccines are administered by or under the direction of a veterinarian.

In the case of vaccines administered by a veterinarian, the exhibitor, upon request by Competition Management, must provide documentation from the veterinarian on documenting that the horse in question received the vaccinations; name of the vaccines and date of vaccine administration.

In the case of vaccines administered by a person other than a veterinarian, the exhibitor, upon request by Competition Management, must provide a receipt of the vaccine purchase which is signed by the owner, or agent with care, custody, and control of the horse; name, serial number and expiration date of the vaccine; and date of vaccine administration.

In the case of a horse that is unable to receive either of the vaccinations due to a history of adverse reactions, the exhibitor, upon request by Competition Management, must provide a letter from the veterinarian on official letterhead stating that the horse in question cannot be vaccinated due to medical concerns and a log of temperatures taken twice daily for the seven days prior to entering the competition grounds. These horses must also have their temperature taken and logged twice daily while on the competition grounds. The log of temperatures should be provided to the Competition Management, steward, or technical delegate when requested.

**RETURNED CHECKS:** Checks returned by the bank for any reason will be charged a \$50.00 NSF fee. Accounts will be given ten days to be paid in full with cash or cash equivalent or they will be turned into the USEF for further disciplinary action.

DOG OWNERS USEF GR1301. 6. DOGS ARE NOT PERMITTED TO BE LOOSE ON THE COMPETITION GROUNDS AND MUST BE HELD ON A LEASH OR OTHERWISE RESTRAINED. INDIVIDUALS MUST NOT LEAD DOGS ON A LEASH WHLE MOUNTED. DOG OWNERS ARE SOLEY RESPONSIBLE FOR ANY DAMAGES, CLAIMS, LOSSES, OR ACTIONS RESULTING FROM THEIR DOGS' BEHAVIOR.DOG OWNERS FAILING TO COMPLY WITH THIS RULE WILL BE ISSUED A YELLOW WARNING CARD AND MAY BE SUBJECT TO PENALTY UNDER CHAPTERS 6 & 7.

**MEDICAL WASTE:** Sharps must be disposed of in containers provided in the barn areas or exhibitors will be subject to sanction.

**PARKING:** The parking of vehicles and horse trailers is not permitted in the barn areas. Upon your arrival, please follow parking signs and/or directions from members of the horse show staff.

RVs and MOTOR HOMES: Arrangements must be made through the Horse Show and entry blank! Spaces are limited and are reserved on a first-paid basis only. To reserve a space, you must include the weekly fee of \$160 along with your entry. These fees are related to enrolling and accommodating the special needs of Horse Show exhibitors and are in the optimum locations to the barns and rings. Any outside reservation whether accidentally or intentionally made by or through any other means will be subject to the following: Immediate removal to an exterior space in the 4-H lot (not convenient to the Horse Show or other services) additional nights' charges will be incurred for a check out later than noon, and/or an extra fee may be charged for equipment and golf cart parking, trailer parking, etc.

MOTORIZED VEHICLES / GOLF CARTS: USEF Rule GR 1301. Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside, will NOT be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described vehicles as long as they are accompanied by an adult with a valid driver's license. The parent(s), legal guardian(s), or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for sanctions against the parent(s), guardian(s) and/or trainer(s) who are responsible for the child committing the offense. Penalties may include exclusion of the child, parent(s) or guardian(s), and/or trainer(s) from the competition grounds for the remainder of the competition and charges being filed against any of these individuals in accordance with Chapter 6. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance equipment for people with disabilities are exempt from this rule.



#### Tucson Fall Festival and Classic – Protocol Working Document

USEF (United States Equestrian Federation) licensed competition "Tucson Fall Festival and Classic Horse Shows" must operate in accordance with the USEF COVID-19 Action Plan. This plan is based on federal, state, and local regulations, WHO recommendations, CDC guidelines and USEF requirements. Participants, this includes owners, lessees, riders, parents, trainers, coaches, grooms, and competition staff, this includes office staff, medical personnel, crew, volunteers, in-gate, announcers, licensed officials, farriers and braiders will agree to follow physical distancing and anyone who is fully vaccinated against Covid-19 is no longer required to wear a facial covering when on the competition grounds.

Tucson Fall Festival and Classic 11/3-11/7 and 11/10-14/2021 will perform the following:

- All staff, volunteers, officials and service providers will self monitor their temperature daily. Anyone who is not
  fully vaccinated must exercise personal responsibility and wear a facial covering/mask and continue to practice
  social distancing and frequent hand washing.
- All staff, volunteers, officials, service providers and participants will sign Waivers and Release of liabilities, Assumption of Risk and Indemnity Agreement provided by USEF and provide emergency information.
- Signage There will be posted signage throughout the Pima County Fairgrounds displaying applicable federal, state and local regulations as well as WHO recommendations and CDC guidelines.
- Stabling area and trailer parking will be assigned and supervised so as to comply with physical distancing.
- Stabling area will be stocked with hand sanitizer.
- Mounting blocks will be available at the show ring, schooling area and stabling area to lessen contact.
- Facility including jumps, toilets, office and water station will be frequently sanitized. Hand sanitizer and hand washing station will be provided.
- Access will be denied to persons with symptoms of COVID-19 persons exposed to COVID-19 and persons with temperatures of 100.4 or higher or persons who have had contact with persons with symptoms of COVID-19.
  - Contact For purposes of this document, contact is defined as any of the following: having been within six (6) feet of an individual for at least 15 minutes who is COVID-19 symptomatic or infected, starting from 48 hours before that person began feeling sick until the time that individual was isolated; having had direct physical contact with a COVID-19 symptomatic or infected individual; having shared eating or drinking utensils with a COVID-19 symptomatic or infected individual; or having cared for, or having been exposed to the sneeze, cough, or other respiratory droplets of a COVID-19 symptomatic or infected person. Anyone who has been in contact with an individual who is confirmed or suspected to be COVID19-positive should quarantine in accordance with CDC Guidelines
- Competition Office will provide hand sanitizers and provide sanitized work areas and implements.
- Trainer/Competitor packets will be organized for pick-up with as little contact as possible, these will include working protocol.
- Monitoring of schooling, competition and exercise areas, restricting the number of people accompanying the horse to the ring and frequent PA announcements will ensure exhibitors of procedures, schedule and protocol.
- The horse show will secure a field coordinator dedicated to monitoring adherence to Action Plan requirements, and who can support USEF Stewards' and Competition Management's efforts to ensure compliance with safety protocols
- All food vendors will be following state guidelines for food services.
- Ribbons and prizes will be provided in a safe manner.
- Enforcement will be the responsibility of the Tucson Fall Festival and Classic competition organizers.

The organizers of Tucson Fall Festival and Classic agricultural event believe everyone needs to set a good example and be mindful to protect the health and safety of all.

\*Please remember that the competition organizers and the officials have the authority to remove from the facility any person who does not comply with the regulations in effect during the Tucson Fall Festival and Classic Horse Show.

<u>CANADIAN EXHIBITORS:</u> The legend "U.S. Funds" must be printed on the face of any Canadian check drawn on a Canadian bank and used to pay any fees for these shows. Entries received that do not adhere to this policy will be returned. No exceptions.

#### MEMBERSHIP, MEASUREMENT & AMATEUR CARDS

All participants (riders, drivers, handlers, owners, trainers, coaches, agents or lessees) must present to the competition secretary a current <u>USEF/USHJA</u> membership card or copy thereof, or he/she will be assessed a \$45/\$30 (or \$75 if both USEF and USHJA) non refundable show pass fee. All junior and pony hunters must possess and present to the horse show office, a current USEF measurement card. All amateur-owners and adult amateurs must present their amateur cards at the time of number pick up. To speed processing, **please** enclose photocopies of these cards with entries

MONEY CLASS ELIGIBILITY: To be eligible for a money and/or jackpot class, entry must have entered and shown in at least one other class at this show.

**SECTION ENTRY FEES:** After showing in the first class of any section requiring a section entry fee, no refunds will be given for scratching classes within the section for any reason.

STABLING AND PADDOCKS: Whether occupied by horses, feed or tack, stalls will be available for \$250.00 without bedding. Stalls are permanent or temporary with doors. Stall floors are clay based. A \$60.00 per day Office/Facility Fee will be charged for horses that are showing which have not purchased a stall. In all cases any horse will have a stall fee or a haul-in fee. Paddocks will be available for \$150.00/\$300.00 per week. Reservations must be made by closing date or paddocks may not be available. Personal schooling rings may be available.

**NON SHOWING HORSES:** Non Showing horses must pay a stall fee, if using a stall, a \$60.00 Office/Facility Fee and a \$50.00 Non Showing Fee. Horses not using a stall will be charged the \$50.00 Non Showing Fee and a onetime per week \$60.00 Office/Facility Fee – in addition, they are subject to all the rules and regulations of the show.

**FEED & BEDDING:** Feed and bedding is available through the horse show office. Orders must be placed in the horse show office by 12:00 noon for same day delivery. For deliveries prior to arrival, please call the fairgrounds office at 520 762 9100. Exhibitors who bring their own shavings will be subject to a disposal fee.

MINOR EXHIBITORS: Parents or guardian of minor exhibitors shall hold the Tucson Fall Festival Horse Show and the Tucson Fall Classic Horse Show, Southwestern Fair Commission DBA as Pima County Fairgrounds and Show Management harmless for injury to such minor.

#### TRAINER SPLITS

The Tucson Fall Horse Shows offer a service to trainers that allows the trainer to purchase shavings, feed, tack stalls, paddocks, golf carts etc. directly from the Horse Show and then split the total amount for some or all of these items and have it charged directly to their client's horse show bill. Any horse show secretary can assist the trainer in this process. Trainer splits will be accepted until noon on Friday (no exceptions) of each show week. Please advise your clients that these charges will appear on their show bill. Only dollar amounts will be split (not quantities) and totals will be rounded up to the next whole dollar amount. Trainers are reminded that this is a service provided by the Horse Show and that doing splits in a timely manner is their responsibility. Additionally, any splits uncollected from the client will revert back to the trainer for payment.

**Please Note:** Only amounts billed by the horse show to the trainer may be included in the split.

#### SCHOOLING POLICY:

<u>HUNTER RINGS</u>: On schooling day, hunter rings will be open for schooling. Times will be posted in the horse show office. Each morning during the show, hunter rings will close 45 minutes prior to the start of classes. Hunter rings may be open for schooling after being reset by the jump crew, time permitting.

**JUMPER RING:** Schooling in jumper rings is not allowed at any time.

**NOTE:** In any case, no schooling will be allowed after 6:00 p.m. in any of the rings.

**HORSE SHOW OFFICE:** The horse show office will be open daily from 7:00 a.m. until ½ hour after the end of classes. The phone number is (520) 762-9108 at message push #4.

**OFFICE/FACILITY/MEDIC FEE:** Every horse entered will be charged an Office Fee of \$60.00.

**REFUNDS:** Before the closing date of entries, all fees shall be refunded. After the closing date of entries, prior to arrival on the show grounds, all fees except a \$25 Show Scratch Fee, the \$60 office charge and the \$250 stall fee shall be refunded only upon presentation of a statement signed by a Veterinarian (or medical doctor in the case of a rider) stating that the horse (rider) is unable to perform in the classes entered. All scratches must be submitted in writing to be considered for a refund; phone call scratches will not be considered. REFUND REQUESTS MUST BE SUBMITTED BY THE END OF THE SHOW. NO REFUND REQUESTS

WILL BE CONSIDERED AFTER THE HORSE SHOW HAS CONCLUDED. AFTER THE CLOSING DATE OF ENTRIES, STALL FEES ARE NOT REFUNDABLE UNDER ANY CIRCUMSTANCES.

**LATE ENTRIES:** There will be a charge of \$60.00 per horse on all entries post marked after the closing date of entries.

**RDNE** Rode Did Not Enter: Entries that show in a class that was not properly entered will be charged the regular class entry fee, plus a \$10.00 RDNE Fee per class.

**PROFESSIONALS:** Please read this and inform your customers that exhibitor numbers will not be issued by the secretary until entry forms are correctly and completely filled out and arrangements for payment are completed. Trainer splits much be completed in the office before 12 noon on Friday.

**ARRIVAL AND DEPARTURE:** Arrival after 10:00 a.m. on Monday/ Departure by 10:00 a.m. on each following Monday. Early arrivals and late departures must be arranged in advance. Contact Jeff Gilbert at 818 259 4459.

## ALL TRAINERS WILL BE REQUIRED TO LEAVE AN OPEN CHECK OR PHOTO COPY OF CREDIT CARD IN THE HORSE SHOW OFFICE UPON CHECK IN.

MEASUREMENTS; Small Hunters Wednesday at 8:00 a.m. Ponies and Junior Hunters Saturday at 8:00 a.m.

<u>COURTESY CIRCLE</u> - Management may at any time decide to limit the Courtesy Circle in any Hunter Class. A notice will be given and the limits of the courtesy will be posted on the course plan and will be announced.

<u>DAY HAULERS</u>: Allowed with prior permission from show management. There will be a day hauler fee of \$50 per horse/per show **and** a \$60 office fee.

#### ATTIRE/HEADGEAR: -

It is compulsory for all persons at Federation licensed hunter, jumper or hunter/ jumper competitions when mounted anywhere on the competition grounds, to wear properly fastened protective headgear which meets or exceeds ASTM (American Society for Testing and Materials)/SEI (Safety Equipment Institute) standards for equestrian use and carries the SEI tag. It must be properly fitted with harness secured. Exception: In Hunter or Jumper classes, adults may be allowed to remove their headgear while accepting prizes and during the playing of the National Anthem only; they must refasten their headgear prior to the lap of honor. It is compulsory for riders in Paso Fino classes, both open and breed restricted including Hunter Hack, where jumping is required and when jumping anywhere on the competition grounds to wear properly fastened protective headgear which meets or exceeds ASTM (American Society for Testing and Materials)/SEI (Safety Equipment Institute) standards for equestrian use and carries the SEI tag. It must be properly fitted with harness secured. A Show Committee must bar riders without protective headgear from entering the ring for classes in which protective headgear is required and may bar any entry or person from entering the ring if not suitably presented to appear before an audience. See USEF GR 801.

All riders must be properly attired. Numbers must be worn and clearly visible. Small euro style tags are not acceptable.

Safe Sport: Beginning December 1, 2018 All Senior members of USEF will be required to complete a Safe Sport training class at USEF.org before competing in a USEF Licensed competition. An exhibitor will not be allowed to compete until this requirement is met.

SAFETY: Accidents Involving Competitors. GR849. In the event of a head injury due to a fall/accident at a licensed competition, the competitor may be prohibited from further competition until released by medical personnel. In some cases, the competitor may not return to competition without a signed release from a licensed medical professional. The competitor may be placed on suspension by USEF until this criteria is met. Competitors are advised to familiarize themselves with this new rule.

#### HORSE REGISTRATION NUMBERS

All horses competing in Federation non breed restricted licensed competitions with hunter, hunter breeding, jumper and hunter seat equitation classes must be properly identified and must obtain a Registration Number from the USHJA. Applications for Registration Numbers can be completed online at <a href="https://www.usef.org">www.usef.org</a> using the Horse Registration application form HORSES MUST STILL BE RECORDED WITH THE USEF (EITHER LIFETIME OR ANNUAL) TO RECEIVE NATIONAL OR ZONE POINTS. See USEF Rules EQ 100.2, HU 101.1, And JP 100.2.

Microchipping: Beginning in the 2018 competition year, all horses competition in USEF licensed and/or USHJA-sanctioned competitions with Hunter, Hunter Breeding, Jumper and Hunter/Jumping Seat Equitation classes not restricted to breed will be required to be microchipped to receive points. The following year, this will be a requirement for all horses competing in these classes. USEF has provided education materials to competitors to learn more about microchipping and the rules.

ENTRY PROCEDURES: Each horse entered in any classes in the Open and Junior/Amateur-Owner/Adult Amateur Jumper sections, must send in the \$120 Jumper Nominating Fee and your stall fee. If you plan to haul in and not use a stall, send any appropriate nominating fees along with a \$60 Office/Facility Fee. Send with your completed entry blank on or before the closing date of entries. Bring a check for the remainder of the fees to the show. NO NUMBERS WILL BE ISSUED WITHOUT FULL PAYMENT. A signed, open check or a photo copy of your credit card must be left for classes that are added during the show. NO STALLS RESERVED WITHOUT PAYMENT IN FULL.

**ENTRY CLOSING:** The entry closing date is October 15, 2021. Entries must be postmarked by this date to be considered ontime. Entries not on time are subject to a \$60 late fee.



A. RULES AND REGULATIONS: I hereby agree to be bound and abide by the rules, regulations, and policies of USEF as published in the USEF Rule Book and on the website at www.usef.org, as amended from time to time.

B. ACKNOWLEDGMENT OF RISK: I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any USEF Event involves risks and dangers including, without limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the USEF Event organizers and competition management; and other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks").
