#### **Entries**

1. Entry Fee - \$3.00 for single birds.

- 2. Entries Shall be entered as breed, variety, sex and age.
- 3. Entries will be judged as singles.
- 4. Entry fee will be forfeited or absent, ineligible or disqualified.

## **Exhibitors Passes/Parking**

Fair Passes Adults \$25.00 Age 6 – 10 \$10.00 Children 5 and under Free

Parking Pass \$20.00 one free pass with entry, additional parking passes

\$20.00 each. Limit 2.

#### Judging:

Judging – Saturday, April 18, 2026, starting at 11:00 am

All judging will be by comparison. Any breed and color recognized by the National Pigeon Association will be eligible for judging. All breeds will be judged as show birds in show coop only – not performance. The judge's decision is final and the judge reserves the right to disqualify any bird not considered to be a representative of a recognized breed. Any person interfering with a judge or the judging procedure will have his/her bird(s) disqualified from the competition.

#### Release

Animals must be removed from the barn no later than 7:00 pm on April 19, 2026. Pima County Fair will not be responsible for birds left after this time. Release slips must be obtained from Show Superintendent prior to leaving. Exhibits not picked up will be dispose of at the discretion of the superintendent.

**Note:** When removing birds, please remove water containers and place on top of cages, then close the cage door.

The barn will be sprayed immediately after the release of birds, the spray can be hazardous to the bird's health.

## **Rules:**

- 1. In all cases, management reserves the right to reject or accept conditionally any entry. Any bird that is unsightly or shows symptoms of disease or parasite infestation will be removed from the show area and entry fee will be forfeited.
- 2. The show management will not be responsible for any damage or death in transit or during the show. Every precaution will be taken to insure against such hazards.
- 3. Eggs laid during the show will become the property of Pima County Fair and must be removed by pigeon department personnel. The pigeon personnel will be responsible for the feeding and watering of exhibits. Feed will be provided by the pigeon show. Arrangements for exhibits requiring special feed must be made with the superintendent prior to the acceptance of the entry. Special food will be provided by the exhibitor and noted on the entry form.
- 4. Sale signs may be posted following the completion of judging and provided by the exhibitor.
- 5. Classes will be provided as such: Old Cocks, Old Hens, Young Cocks, Young Hens and Baby. Baby class must be at least 6 weeks old to compete. No substitutions (except band numbers) will be permitted After April 11, 2025. Only bands of reputable organizations will be recognized.
- 6. If there are not enough birds to fill a class, the superintendent reserves the right to combine colors.
- 7. All birds entered as young birds must have a 2025 seamless band of proper size. Oversized, split or spiral bands must be entered as old birds. Babies should have 2026 bands.
